Re: Law Book Update No. 3

- 1. Remove all printed pages from the book, leaving only the tab sheets, as well as any bulletins or newsletters you may have saved in the back of the book.
- 2. Insert pages <u>I-1 through 8</u> in front of the *Table of Contents* tab.
 - We have updated the Directory
- 3. Insert pages <u>I–9 through 16</u> immediately following the *Table of Contents* tab.
 - We have revised this section to reflect the new laws and rules added.
- 4. Insert pages II-1 through 24 immediately following the Title 37 tab.
 - §1203 was amended to reduce one of the restrictions on licensure by reciprocity.
 - §1226.2 was amended to allow more donations of drugs to charitable pharmacies.
 - §1232 was amended to change certain requirements for out-of-state pharmacies to be consistent with in-state pharmacies.
 - §1241.A.17.c was amended to remove the handwriting requirement for certain prescriptions reimbursable by Medicare.
- 5. Insert pages <u>III–1 through 52</u> immediately following the *Title 40* tab.
 - §964 was amended to move Methaqualone from Schedule II to I; to move Buprenorphine from V to III; to remove Nalbuphine from IV; and to add several new drugs missing from IV.
 - §967 was amended to increase the penalties for illegal activities involving Methadone.
 - §971 was amended to require all pharmacies to require recipients of prescriptions for controlled substances to produce photo identification prior to receiving the medication, unless already known to the pharmacist.
 - §971.2 was amended to increase the fine from \$5,000 to \$50,000.
 - §973 was amended to transfer the authority for the issuance of all CDS permits to the Board of Pharmacy.
 - §981.3 was amended to include designated child day care centers in drug-free zones, with increased penalties for violations of CDS rules.
 - Part X-A, known as the Prescription Monitoring Program Act, added.

- Chapter 5 added, including §1238.1, which criminalizes the possession of prescription drugs without a valid prescription. §1238.2 adds corresponding responsibility to pharmacists for legitimacy of prescriptions for legend drugs.
- Chapter 11 added, including requirements for licensure of pain management clinics. This law requires certain regulations to be promulgated; we will advise you when that action has been completed.
- 6. Insert pages <u>IV-1 through 92</u> immediately following the *Title 46* tab.
 - §705.C.1.b was amended to remove certain restrictions on the nature of practical experience earned by pharmacy interns during their academic rotation programs at colleges of pharmacy.
 - §907.A was amended to provide some flexibility in the maximum ratio of pharmacy technicians to pharmacists.
 - §907.C was amended to increase the scope of practice for pharmacy technicians.
- 7. Insert pages <u>V-1 through 4</u> immediately following the CDS Info tab.
 - The DEA updated their Pharmacist's Manual in April 2004.
 - New information summarizing all prescribers with privileges for controlled substances.
- 8. Insert pages <u>V–5 through 6</u> immediately following the *Forms* tab.
 - We have updated the listing of forms and applications available on our website.
- 9. Insert pages <u>V–7 through 8</u> immediately following the *Index* tab.
- 10. Insert pages <u>V–9 through 10</u> immediately following the *Bulletins* tab.
