7 seven *(name them?)* chemicals to Schedule I.

9 AN ACT

10

11 To amend and reenact R.S. 40:961 and 40:964, to define the term “hemp” and amend the
12 definition of the term “marijuana”, to add seven new chemicals to Schedule I, and to
13 modify the description of the term “tetrahydrocannabinols” in Schedule I.

14 Be it enacted by the Legislature of Louisiana:

15 Section 1. R.S. 40:964 is hereby amended and reenacted to read as follows:

16 §964. Composition of schedules

17 * * *

18 Schedule I

19 A. Opiates.

20 Unless specifically excepted or unless listed in another schedule,
21 any of the following opiates, including their isomers, esters, ethers, salts, or
22 salts of isomers, esters, and ethers, whenever the existence of such isomers,
23 esters, ethers, or salts is possible within the specific chemical designation:

39 Unless specifically excepted or unless listed in another schedule, any

40 material, compound, mixture, or preparation which contains any quantity of

41 the following hallucinogenic substances, or which contains any of their salts,

42 isomers, or salts of isomers, whenever the existence of such salts, isomers, or

43 salts of isomers is possible within the specific chemical designation; for

44 purposes of this Paragraph only, the term “isomer” includes the optical,

45 position, and geometric isomers:

Section 2. R.S. 40:961 and 40:964 are hereby amended and reenacted to read as follows:

§961. Definitions

As used in this Part, the following terms shall have the meaning ascribed to them in this Section unless the context clearly indicates otherwise:

* * *

(26) *Marijuana*, (a) subject to the provisions of (b) and (c), means all parts of plants of the genus *Cannabis*, whether growing or not; the seeds thereof; the resin extracted from any part of such plant; and every compound, manufacture, salt, derivative, mixture, or preparation of such plant, its seeds or resin,;

(b) but shall not include:

- (i) hemp; or
- (ii) the mature stalks of such plant, fiber produced from such stalks, oil, or cake made from the seeds of such plant, any other compound, manufacture, salt, derivative, mixture, or preparation of such mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of such plant which is incapable of germination,;

(c) and shall not include ~~or~~ cannabidiol when contained in a drug product approved by the United States Food and Drug Administration.

(45) *Hemp* means the plant *Cannabis sativa* and any part of that plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, and salts of isomers, whether growing or not, with a delta-9-tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis.

87 (27) Tetrahydrocannabinols, including synthetic equivalents and derivatives,
88 except for tetrahydrocannabinols in hemp.
