# Consideration of Minutes from July 8, 2009 Meeting

Minutes were approved by consensus of the Council.

#### **Review of Program Operation**

The law enforcement enhancement (at a cost of \$30,000) to the PMP was approved by Board at its August meeting and will be implemented shortly.

# Report from 5<sup>th</sup> Annual National Prescription Drug Monitoring Program Conference

The 5<sup>th</sup> Annual National Harold Rogers PDMP Meeting was held in Washington, D.C. September 24-25, 2009.

33 states currently have operational PMPs; Washington would have made it 34 but that state had to suspend operations due to lack of funding. 7 states have enacted legislation and are in the process of becoming operational. 10 states have no legislation.

Mr. Fontenot reviewed several topics discussed at the meeting with the Council.

On the issue of *frequency of reporting* Louisiana law states that the frequency of reporting shall not be more than once per week. Louisiana's PMP regulations state the frequency of reporting shall be at least every 14 days. Because of federal grant requirements the trend is a 7 day or less reporting frequency. Oklahoma will have the capability of point-of-sale (POS) reporting by 2012. A primary reason given for this move is for emergency room physicians to have real time access for queries.

Daily reporting or POS reporting is the trend nationwide. Mr. Fontenot suggested Louisiana may want to consider changing our frequency in the future. The members were asked to discuss the topic with their respective agencies and organizations for discussion at a later PMP meeting.

Mr. Fontenot stated another national trend is to use the **ASAP 2007 reporting format**. Louisiana currently uses the ASAP 1995 format. POS reporting would require ASAP 2007 and captures the method of payment the patient uses.

On the issue of *Interstate Sharing of PMP data* Mr. Fontenot explained a pilot project in current operation between Kentucky and Ohio which has successfully performed the sharing of PMP data using test patient accounts.

The funding of the sharing mechanisms as well as the housing of the data were the primary topics of interest to the Council.

Request for Access to Program from Out-of-State Law Enforcement Agencies

After a discussion on whether the Louisiana PMP statutes allow for the sharing of PMP data with out-of-state law enforcement agencies, the Council agreed to recommend to the Board of Pharmacy that it amend the statutes to specifically grant access in this manner. Until that time, Major Staton suggested out-of-state agencies work with local and federal law enforcement on cases as join investigations to acquire needed PMP information under current authorization venues.

Also discussed was whether an out-of-state practitioner with a Louisiana residentpatient relationship can have access to that patient's PMP records. The statutes are silent on the issue.

Col. Tafaro listed the following possible changes to the PMP statutes:

- (1) access by both out-of-state law enforcement and out-of-state regulatory boards
- (2) Medical psychologists are now under the regulatory jurisdiction of the Medical Board. Therefore, the Louisiana State Board of Examiners of Psychologists should be removed from membership on the PMP Advisory Council.
- (3) Development of emergency access plan language to PMP data.
