### Consideration of Minutes from the October 10, 2018 Meeting

#### **Review of Program Operation**

Mr. Fontenot, Assistant Executive Director, informed the Advisory Council that a new contract with our current software vendor, Appriss Health, was approved for another five years of service. Furthermore, Mr. Fontenot explained the following enhancements included in the new contract: automatic registration process for pharmacists and medical interns, clinical alerts, advanced analytics, prescriber report cards, and mandatory use compliance. President Aaron asked if the clinical alerts enhancement would provide the same or similar information to the service proposed by FraudRx Alert at the last meeting. The council discussed the matter and due to the clinical alerts enhancement included in the new contact, no one was in favor of providing FraudRx Alert third-party access to the program's data.

Mr. Fontenot provided an update on the grant awarded to the program, letting the council know that we entered an interagency contract with Louisiana Department of Health (LDH) for thirty one (31) months of statewide use of Gateway and NarxCare services at no cost for all prescribers and dispensers.

Mr. Fontenot informed the council of Legislative Proposal 2019-C ~ Access to PMP. Maj. Bob Brown motioned to approve the proposal as it is written. Dr. Vincent Culotta, Jr. seconded the motion. (Attachment 1)

Mr. Joe Fontenot presented statistical information regarding the program to the council. (Attachment 2)



1 HLS 19-2 Regular Session, 2019 3 House Bill No. 4 By Representative 5 6 CONTROLLED SUBSTANCES: Authorizes prescription monitoring program connection to 7 similar programs in federal jurisdictions and to electronic health record systems. 8 9 AN ACT 10 To amend and reenact R.S. 40:1007, relative to access to prescription monitoring information 11 12 and audit trail information. Be it enacted by the Legislature of Louisiana: 13 Section 1. R.S. 40:1007 is hereby amended and reenacted to read as follows: 14 15 §1007. Access to prescription monitoring information and audit trail information 16 G. The board may provide prescription monitoring information in response to 17 queries from prescription monitoring programs, electronic health information 18 systems and pharmacy information systems located in other states and federal 19 20 jurisdictions, through its participation in a secure interstate data exchange system, and the information may be used by those programs in a manner 21 consistent with this Section. 22 23 24




# PRESCRIPTION MONITORING PROGRAM (PMP)



# NUMBER OF ELIGIBLE PRESCRIPTION TRANSACTIONS REPORTED TO THE PMP






